

**SUPPLEMENTAL OFFICIAL RULES FOR COLLECT 'N WIN PICK-3 AND PICK-4 Promotion**  
**Effective September 7, 2021 – September 30, 2021**

The New Jersey Lottery is conducting an additional Collect 'N Win Pick-3 and Pick-4 promotion ("Promotion" or "Pick-3 and Pick-4 Promotion") whereby players who purchase and enter a Pick-3 and/or Pick-4 ticket(s) valued at \$1 or more between September 7, 2021 – September 30, 2021 ("Eligible Pick-3 and Pick-4 Ticket") are eligible to participate. The Promotion is governed by these Supplemental Official Rules for Collect 'N Win Pick-3 and Pick-4 Promotion ("Supplemental Official Rules"). To participate in the Promotion, players must have already Registered for a New Jersey Lottery VIP Club Account and may download the New Jersey Collect 'N win app for iOS devices or direct download for Android devices, or by visiting NJCollectAndWin.com. 1. The Promotion Period for the Promotion is defined as: approximately 05:00 AM September 7, 2021 – 02:00 AM October 1, 2021.
2. During the Promotion Period, players (sometimes referred to as "you" or "your") who enter an Eligible Pick-3 and/or Pick-4 Ticket into Collect 'N Win will randomly be awarded one (1) of the following on a per ticket basis:
  - 2X the symbols
  - 3X the symbols
  - 4X the symbols
  - 5X the symbols
  - One (1) \$2 Instant Cash Voucher
  - One (1) \$5 Instant Cash Voucher
  - One (1) \$10 Instant Cash Voucher

Players awarded the 2X the symbols, 3X the symbols, 4X the symbols, and/or 5X the symbols in connection with the Promotion will have those symbols and/or complete card applied in their player account to be used in the next available monthly Collect 'N Win drawing conducted in accordance with the Official New Jersey Lottery Collect 'N Win Rules & Drawing Procedures.

Players awarded one (1) of the \$2 Instant Cash Vouchers, \$5 Instant cash Vouchers, and/or \$10 Instant Cash Vouchers will instantly receive a voucher barcode that will be stored in their player account and can be accessed and redeemed immediately. To redeem one (1) of the \$2 Instant Cash Vouchers, \$5 Instant Cash Vouchers, and/or \$10 Instant Cash Vouchers, you must present the Voucher Barcode to a New Jersey Lottery licensed retailer. A Voucher Barcode may be presented to a New Jersey Lottery licensed retailer via a mobile device or printed copy. \$2 Instant Cash Vouchers, \$5 Instant cash Vouchers, and/or \$10 Instant Cash Vouchers are only valid for a single redemption. All vouchers will expire on October 31, 2021. The New Jersey Lottery is not responsible for lost, stolen, damaged or expired vouchers.

3. Players must be 18 years or older and a legal resident of the United States or District of Columbia to play and participate in the Promotion. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.S.A. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Promotion.
4. The New Jersey Lottery may declare any Eligible Pick-3 and/or Pick-4 Ticket purchased during the Promotion Period void if it is stolen.
5. Per the Official New Jersey Lottery Collect 'N Win Rules & Drawing Procedures, New Jersey Lottery licensed retailers are not eligible to participate in this Promotion. At the conclusion of the Promotion Period, the New Jersey Lottery may, at its sole discretion, conduct an audit to determine which player accounts received any of the \$2 Instant Cash Vouchers, \$5 Instant Cash Vouchers, and \$10 Instant Cash Vouchers. The New Jersey Lottery reserves the right to adjust and debit accordingly from a New Jersey Lottery licensed retailers weekly invoice the value of any and all Instant Cash Vouchers issued to a New Jersey Lottery licensed retailer in connection with his/her participation in the Promotion. The New Jersey Lottery may make exceptions for and disqualify New Jersey Lottery licensed retailers from participating in the Pick-3 and Pick-4 Promotion at any time during the Promotion Period as deemed necessary by the New Jersey Lottery, in its discretion, to ensure the integrity of the Pick-3 and Pick-4 Promotion and/or when such action is determined by the New Jersey Lottery, in its discretion, to be in the best interest of the New Jersey Lottery.
6. The New Jersey Lottery reserves the right, without prior notice, to cancel, terminate, modify or suspend the Pick-3 and Pick-4 Promotion at any time and for any reason, including but not limited to if the New Jersey Lottery determines that a virus, bug, unauthorized human intervention, fraud or other cause has or is corrupting or affecting the administration, security, fairness or proper conduct of the Pick-3 and Pick-4 Promotion. In such a case, the New Jersey Lottery or its designee, in its sole discretion, may select winners from all eligible entries received prior to or after resolution of (if appropriate) the Event. The New Jersey Lottery or its designee reserves the right, in its sole discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process for the Pick 3 and Pick 4 Promotion, the operation of the Promotion or otherwise violates these Official Rules. The New Jersey Lottery or its designee has the right, in its sole discretion, to maintain the integrity of the Promotion and to void an entry for any reason, including the use of bots, macros or scripts or other technical means for entering.
7. By participating in the Promotion, you agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC (collectively "Affiliates"), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your participation in the Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the Promotion, any defect with the Promotion, and/or any error in the administration or operation of

the Promotion. You, on behalf of yourself, your spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to you or your property that you may have against the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates, arising out of or associated with your participation in the Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the Promotion, any defect with the Promotion, and/or any error in the administration or operation of the Promotion.

8. By participating in the Promotion, you hereby irrevocably consent to the use of your name, town and state of residence, prize, photograph(s), video(s), voice, and likeness by the New Jersey Lottery and its agents, representatives and designees, in any and all of the New Jersey Lottery's online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to you. You hereby irrevocably authorize the New Jersey Lottery and its agents, representatives and designees to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by you, your name, town and state of residence, prize, photograph(s), video(s), voice, and likeness for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, you hereby irrevocably waive any right to royalties or other compensation arising from or related to the use of your name, town and state of residence, prize, photograph(s), video(s), voice, and likeness. You hereby hold harmless and forever release, discharge and indemnify the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action, loss or demand, known or unknown, which you, your heirs, agents, representatives, executors, administrators, or any other persons acting on your behalf or on behalf of your estate have or may have by reason of this Image Authorization, including without limitation, all claims for invasion of privacy, right of publicity, defamation, false endorsement, and any other claims regarding personal and/or property rights. The New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.) allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous. This does not apply to the Promotion.
9. By participating in the Pick-3 and Pick-4 Promotion, New Jersey Lottery licensed retailers and players agree to fully comply with these Supplemental Official Rules and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Pick-3 and Pick-4 Promotion. The Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.
10. These Supplemental Official Rules may be changed at any time without prior notice if determined, in the sole discretion of the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.

11. All winners, tickets and transactions in connection with the Pick-3 and Pick-4 Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Pick-3 and Pick-4 Promotion may be subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. The New Jersey Lottery is not responsible for lost or stolen tickets. The Pick-3 and Pick-4 Promotion is void where otherwise prohibited by law. Pick-3 and Pick-4 Promotion not valid in combination with any other New Jersey Lottery promotion or coupon.
12. Winners are solely responsible for payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the Pick-3 and Pick-4 Promotion and/or the monthly Collect 'N Win drawings.
13. Promotion odds vary based on amount of Eligible Pick-3 and Pick-4 Tickets entered into the Promotion.
14. The invalidity or unenforceability of any provision of these Supplemental Official Rules will not affect the validity or enforceability of any other provision of these Supplemental Official Rules. In the event that any provision of these Supplemental Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The Lottery's failure to enforce any provision of these Supplemental Official Rules will not constitute a waiver of that or any other provision of these Supplemental Official Rules.
